

# **Level 2 Award in Fire Safety**

## Who should attend

The QA Level 2 Award in Fire Safety (RQF) is a regulated and nationally recognised qualification that has been specifically designed for anyone who has a specific responsibility for fire safety in the workplace, such as designated fire wardens/fire marshals.

#### **Course information**

#### Overview

This course is designed for all employees as an introduction to fire awareness and is an excellent addition to include in your company induction programme for new employees as CPD regulated training. It deals with how fires can occur and what to do in the event of a fire. The course also provides a foundation for those employees who want to develop their basic fire safety awareness in order to assist their employer by progressing to more specific fire safety roles in the workplace to manage fire risk (see our Fire Warden/Marshal course).

The Fire Safety Order requires that fire safety training is provided to staff when they commence employment and that refresher training is provided on a regular basis.

# **Legal Requirements**

The Regulatory Reform (Fire Safety) Order 2005, under regulation 21 Training states you must include suitable and sufficient instructions and training on the appropriate precautions and actions to be taken by the employee in order to safeguard himself/herself and other relevant persons in the premises. A suitable and sufficient Fire Risk Assessment will also allow you to determine the extent of training that may be required depending on hazards on site.
